- a) Holder of Bachelor of Business Administration or related fields such as; BAPRM, BAMC, BSCT Bachelor of Science in Statistics, BSc. In Procurement, Bsc. In Engineering, and BA of Medicine. With a GPA of 2.8 and above from any institution of Higher Learning recognized by the Tanzania Commission for University.
- b) Holder of Bachelor of Business Administration or related fields such as; BAPRM, BAMC, BSCT Bachelor of Science in Statistics, BSc. In Procurement, Bsc. In Engineering, and BA of Medicine. With a minimum GPA of **2.7 plus five years of work experience.**
- c) Applicant with professional qualification such as CPA (T), CSP (T), NBAA, Or ACCA holders with background in Business.
- d) Holder of Postgraduate Diploma in Accountancy and Finance or Business with a GPA of 3.0.
- e) Holder of Advanced Diploma in Accountancy and Finance or Business with a GPA of 3.0 and above from any institution of Higher Learning recognized by the Tanzania Commission for University.
- f) Applicants with unclassified Bachelor Degree the GPA should be computed and criteria should apply.

MASTER OF ARTS IN MASS COMMUNICATION (MAMC)

Admission criteria

- b) Holder of Bachelor Degree in Mass Communication with a minimum GPA of **2.7 plus five** years of work experience in related field.
- c) Holder of Postgraduate Diploma in Mass Communication with a GPA of 3.0 and above from any institution of Higher Learning recognized by the Tanzania Commission for University.
- d) Applicants with unclassified Bachelor Degree the GPA should be computed and criteria should apply.

MASTER OF ARTS IN ECONOMICS (MAEC)

Admission criteria

An applicant must satisfy of the following requirements:-

- a) Holder of Bachelor of Arts in Economics or Bachelor of Arts in Education with Specialization in Economics with a GPA of 2.8 and above from any institution of Higher Learning recognized by the Tanzania Commission for University.
- b) Holder of Bachelor of Arts in Economics or BAED with Specialization in Economics with a minimum GPA of **2.7 plus five years of work experience.**
- c) Holder of Advanced Diploma in Economics with a GPA of not less than 3.0 from any institution of Higher Learning recognized by the Tanzania Commission for University.
- d) Applicants with unclassified Bachelor Degree the GPA should be computed and criteria should apply.

MASTER OF LAWS (LLM)

Admission criteria

An applicant must satisfy of the following requirements:-

- a) Holder of Bachelor Degree in Law with a GPA of 2.8 and above from any institution of Higher Learning recognized by the Tanzania Commission for University.
- b) Holder of Bachelor Degree in Law with a minimum GPA of **2.7 plus five years of work experience in related field.**
- c) Holder of Postgraduate Diploma in Law with a GPA of 3.0 and above from any institution of Higher Learning recognized by the Tanzania Commission for University.
- d) Advanced Diploma in Law with a GPA of 3.0 and above.
- e) Applicants with unclassified Bachelor Degree the GPA should be computed and criteria should apply.

MASTER OF ARTS IN LINGUISTICS (MAL)

Admission criteria

An applicant must satisfy of the following requirements:-

- a) Holder of Bachelor Degree in Education (BED) or with a specialization in the Languages with a GPA of 2.8 and above from any institution of Higher Learning recognized by the Tanzania Commission for University.
- b) Holder of Bachelor Degree in Education or Languages with a minimum GPA of 2.7 plus five years of work experience in related field.
- c) Holder of Postgraduate Diploma in Education or languages with a GPA of 3.0 and above from any institution of Higher Learning recognized by the Tanzania Commission for University.
- d) Applicants with unclassified Bachelor Degree the GPA should be computed and criteria should apply.

MASTER OF EDUCATION MANAGEMENTAND PLANNING (MEMP)

Admission criteria

An applicant must satisfy of the following requirements:-

- a) Holder of Bachelor Degree in Education (BED) with a GPA of 2.8 and above from any institution of Higher Learning recognized by the Tanzania Commission for University.
- b) Holder of Bachelor Degree in Education with a GPA of **2.7 plus five years of work experience in related field.**
- c) Holder of Postgraduate Diploma in Education with a GPA of 3.0 and above from any institution of Higher Learning recognized by the Tanzania Commission for University.
- d) Applicants with unclassified Bachelor Degree the GPA should be computed and criteria should apply.

MASTERS OF HIGHER EDUCATION MANAGEMENT AND DEVELOPMENT (MEMD)

- a) Holder of a first degree, preferably in related discipline with a GPA of 2.8 and above from any institution of Higher Learning recognized by the Tanzania Commission for University.
- b) Holder of Bachelor Degree in related discipline with a GPA of **2.7 plus five years of work experience in related field.**
- c) Have 5-10 years' leadership or management experience at least at middle level (academic or non academic) and have the aspiration to senior roles in University Management.
- d) Holder of Postgraduate Diploma in Education with a GPA of 3.0 and above from any institution of Higher Learning recognized by the Tanzania Commission for University.
- e) Applicants with unclassified Bachelor Degree the GPA should be computed and criteria should apply.

POSTGRADUATE DIPLOMA IN ACCONTACY AND FINANCE

Admission criteria

a) A candidate should be a holder of a Bachelor Degree or Advance Diploma with a GPA of not less than **2.0** (Pass Class) in a related field of duration not less than three years from a recognized Higher Learning Institution.
